Sworn statement:

At the time of signing this contract, the owner of the mare guarantees that the mare / foal or other horses the mare / foal has been in contact with for the past 6 weeks, has not shown or shows any signs of infectious diseases.

The mare owner guarantees that the mare / foal has not had strangles and guarantees that the mare / foal has not been in contact with strangle infected horses for the past 3 months.

Practical:

- Covering takes place at Kronholt, Krøjtårdsvej 25, 7400 Herning.
- Only covering by hand is offered.
- Mares without foals are not covered until a clean uterine sear is shown.
- The mare must meet without shoes.
- Horse passport must be brought and will be stored by Kronholt during the stay.
- The mare must be grazed in before arrival (special arrangement may be made).
- Please inform on arrival if the mare has any special issues. (Example: summer exema)
- It is recommended that the mare is insured, vaccinated and examined for worms.
- No re-cover is offered, but if the mare is not found pregnant within 60 days after the last cover, 1.330 € + VAT is refunded. The mare owner must report this within 60 days from the date the mare was collected.

During the stay:

- All mares will be covered by hand under good and proper conditions.
- The stay for mares and eventual foals is at the owner's own expense and risk. This applies in all cases, during covering as well as on fold and in box.
- Kronholt reserves the right to call a veterinarian at our discretion at the owner's expense.
- The owner gives Kronholt the authority to transport the horse if this is found necessary.
- Kronholt reserves the right of retention of the horse, whose owner does not meet the financial obligations.
- Every mare and foal will be inspected daily.
- All horses go on grass fold, alternatively, fold with hay ad libitum.

- If extra feeding is necessary, this is initiated after contact with the owner.
- Mares that exhibit aggressive behavior in the flock are moved to separate folds. The owner will be advised.

Prices:

Cover fee: 1.600 € + VAT

Of which booking price: 270 € + VAT (Payable upon booking)

Of which spring charge: 270 - Kr. + VAT (Not refundable for loss of fetus)

Certificate for DI: 45 € incl. VAT

Grass money: 10 € / day + VAT

If the mare loses her fetus within 60 days of the last covering 1.330 € + VAT will be refunded.

Veterinary certificate must be presented before the amount is refunded.
